- 1. Method of Procurement is single stage, one envelops bidding procedure in accordance with Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KPPRA) Rules 2014.

- 4. Earnest money (from the firm/company account only) as mentioned in the bidding documents for each package must accompany with the bid in shape of Call Deposit in the name of CEO, WSSC, Kohat Bank of Khyber A/C# 0138000000712002 by 5th March 2021.
- 5. A pre-bid meeting will be held at the address given below at 11:00 AM on 24th March, 2021.
- 6. The tender documents must be signed by contractor/Firm or authorized person of the firm.
- 7. Bid must be delivered on or before 05th April, 2021 at 04:00 PM through registered courier service only. Bids will be opened on 6th April, 2021, 02:00 PM at the address mentioned below in the presence of the bidders or their authorized representative to participate in the tender opening process. WSSC will not be responsible for any cost or expenses incurred by Bidders in connection with the delivery of bids.
- 8. Payment to the successful bidder will be made on the work done monthly basis, for the 65 number of tube wells and pump house in the jurisdiction of WSSC Kohat.
- 9. The WSSC Kohat will hand over all the tube wells in working condition to the successful contractor.
- 10. The contractor should have sufficient numbers of spare motors/pumps at their stock/workshop of each capacity for replacement of the damaged Motors/pumps.
- 11. The contractor should have sufficient numbers of spare transformers at their stock/workshop of each capacity for replacement of the damaged transformers.
- 12. All federal and provincial duties/stamp duty/taxes including Income Tax, sale tax and KPRA registered will be recoverable as per directives of the government issued from time to time.
