

INTRODUCTION.

Water and Sanitation Services KOHAT (WSSCK) is an autonomous body which provides facilities related to Drinking Water, Sanitation and Drainage to the inhabitants of KOHAT. RFQ are invited from approved/registered and reputed insurance companies having established office(s) at Kohat orwsse & Peshawar and registered with Sales Tax Department, having National Tax Number (NTN), for providing Group Life Insurance services to the employees of WSSCK. The Insurance Companies should have 7-10-years' experience in rendering similar services

TASKS TO BE PERFORMED BY THE INSURER.

- a. To provide Life Insurance Coverage to all regular employees (As per Annex A) of WSSCK
- b. To coordinate the matters / affairs with any authorized officer of WSSCK regularly.

RESPONSIBILITIES OF WSSCK.

- a. WSSCK will provide the scope of work outlining the number of employees to be insured along with their required benefit structure and additional benefits to cover.
- b. The Interest Insurance Company should cover all the desired benefits and quote their rates accordingly, if all the benefits / Riders are not provided the firm shall be considered as nonresponsive.
- c. WSSCK will bear the cost of premium based on the details provided under the scope of work.

ELIGBILITY CRITERIA OF INSURER.

- Approved/ credible Insurer, preferably with AA / A+ credit ranking and registered with • Government (Federal or Provincial)
- Must be registered with Tax Authorities and having valid registration of Sales Tax and Income Tax, KPRA and also having sound financial strengths can participate.
- Has submitted bid for all quoted categories and relevant bid security. Noncompliance of the • same shall cause rejection of the bid.
- Has not been blacklisted by any of Provincial or Federal Government Department, Agency, • Organization or autonomous body or Private Sector Organization anywhere in Pakistan

- Period of payment of Claims should be within 07 to 15 days after receipt of such claim. 12.
- Bidder should quote their firm and final rates both in words as well as in figures. 13.
- Erasing / outing / crossing / over writing etc. if any, appearing in the offer must be 14. properly signed by the person signing the Bid, Moreover, all pages of the Bid must also be properly signed.
 - No incomplete, supplementary or revised offer shall be accepted after opening of the Bid.

- 20. All the clauses related to the payment of death claims of deceased WSSCK employees mentioned here in the Bid document, will also be a part of the contract which will be made with the successful bidder.
- 21. Death Benefits: if any employee dies while insured under the policy, the Insurer will pay the amount of group insurance / death benefit equal to the amount given below for which the employee is ensured under the policy.
- 22. It would be 24 hours coverage in case of death due to any cause.
- 23. In case of revision of rate of benefit by the Government during the currency of the contract, the contractor would be bound to pay according to revised rates without revising the rates premium or other Terms & Conditions.
