4. Each envelope must contain separate Technical and Financial bids, clearly marked in bold and legible letters. Bids must be uploaded on the EPADS software, and a sealed hard copy of the documents, as required under the technical criteria, must be submitted complete in all respects must reach the office of the undersigned on or before 08th September 2026 at 11:00 AM. The technical bid will be opened on the same day at 11:30 AM in the presence of the Procurement Committee and the bidders or their authorized representatives.
5. Any bidder who fails to upload their bid & CDR on the e-procurement software (EPADS) and submits only a sealed bid will be considered non-responsive, and their bid will not be entertained.
